RE: CSEA Public Notice Letter – Successor Year 2024-2025

Dear Superintendent Garbolino-Mojica:

Pursuant to Government Code Section 3547, the California School Employees Association, and its Placer COE Chapter #479 (CSEA) hereby present its Initial Proposal for the 2024-2025 successor year as follows:

Article 4-Organizational Rights-CSEA hereby proposes increasing the number of CSEA committee members who are entitled to release time.

Article 6-Hours and Overtime-CSEA hereby proposes an alternative work week schedule.

Article 8 Payroll and Allowance-CSEA hereby proposes a fair and equitable increase in Classified salaries. CSEA hereby proposes adding the Educational Interpreters MOU to the CBA.

Article 10- Health Welfare Benefits-CSEA hereby proposes a fair and equitable increase to Classified Health and Welfare Benefits.

Article 12-Vacation-CSEA hereby proposes adding language to approval of vacation days.

Article 13-Leaves-CSEA hereby proposes adding language for disaster days, personal necessity, emergency closure days.

Article 20-Safety-CSEA hereby proposes adding language for nursing mothers.

Article 22-Negotiations Procedures-CSEA hereby proposes language that all members of CSEA's negotiations will be paid for release time and/or reimbursed for the time of negotiations.

Article 23-Duration- CSEA hereby proposes a new contract term from July 1, 2024, through June 30, 2027.


