## 2021-22 School Overview

Mission Statement: The Student Services Department will increase student achievement through meaningful and rigorous instruction for all students.

Situated in the Sierra Foothills, Placer County Office of Education (PCOE) serves over 75,000 students in 16 school districts across Placer County. To serve the students of Placer County, PCOE provides an array of programs and services to meet student needs. This task is accomplished by providing high-quality, specialized programs for students, recruiting, retaining, and developing highly qualified staff, and monitoring fiscal accountability and expenditures.

The Honour Schaps Court School is operated by the Placer County Office of Education and serves incarcerated youth in our community. Honour Schaps Court School typically serves students for less than 30 days. During the 2020-2021 school year, 118 students in grades 7 through 12 were served at Honour Schaps Court School.

Honour Schaps Court School provides intensive intervention tailored to students' academic and social-emotional needs. Common Core State Standards-based curriculum and instruction are provided to all students. Whole group instruction, as well as individualized interventions, facilitate academic, social, and emotional achievement. Honour Schaps Court School has a low staff-to-student ratio, enabling teachers to provide differentiated, meaningful, and rigorous instruction. Honour Schaps Court School provides counseling to students who need social-emotional support and interventions related to anger management and appropriate choice making. Academic and Career Counseling is provided, and a broad course of study is available using a blended model of in-class instruction and online coursework. The school-specific demographic data reported below was collected in October of 2020. However, this data can be highly variable due to the transient nature of the student population.

Demographic data: 30% Hispanic, 10% Asian, 10% Hawaiian/Pacific Islander, 50% White, 10% English Learners, 60% Special Education, 40% Socio-Economically Disadvantaged, 30% Foster Youth.

## 2021-22 Quality, Currency, Availability of Textbooks and Other Instructional Materials

Placer County Office of Education held a public hearing on September 9th, 2021. It determined that each school within the district had sufficient and good quality textbooks, instructional materials, and science lab equipment according to the settlement of Williams vs. the State of California.

All students, including English language learners, are given individual standards-aligned textbooks or instructional materials in core subjects for use in the classroom and to take home. Books and supplementary materials are adopted according to a cycle developed by the California Department of Education, making the textbooks the most current available in the school. All teachers review materials approved for use by the State, and a recommendation is made to the School Board by a selection committee composed of teachers and administrators. Before adoption, all recommended materials are available for parent examination at the district office. The table displays information about the quality, currency, and availability of the standards-aligned textbooks and other instructional materials used at the school.

#### Statewide Assessments

Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. The assessments were required to be:

- Aligned with CA CCSS for ELA and mathematics;
- Available to students in grades 3 through 8, and grade 11; and
- Uniformly administered across a grade, grade span, school, or district to all eligible students.

#### Options

Note that the CAAs could only be administered in-person following health and safety requirements. If it was not viable for the LEA to administer the CAAs in person with health and safety guidelines in place, the LEA was directed to not administer the tests. There were no other assessment options available for the CAAs. Schools administered the Smarter Balanced Summative Assessments for ELA and mathematics, other assessments that meet the SBE criteria, or a combination of both, and they could only choose one of the following:

- Smarter Balanced ELA and mathematics summative assessments;
- Other assessments meeting the SBE criteria; or
- Combination of Smarter Balanced ELA and mathematics summative assessments and other assessments.

## 2021-22 School Safety Plan

All Placer County Office of Education (PCOE) school sites are in the process of updating their 2021-2022 comprehensive school safety plan in accordance with Superintendent Policy 0450 to fulfill the requirements of California Education Code 32280 through 32289. In compliance with SB 187, the plan will be reviewed and revised annually for each school site by the School Site Council/School Safety Committee, reviewed in consultation with law enforcement and first responders, and approved by the County Superintendent of Schools by March 1, 2022. Site safety plans are aligned with the National Incident Management System (NIMS) and California Standardized Emergency Management Systems (SEMS) utilizing the Incident Command System (ICS). Each document is prepared for employees to use at specific school sites in the event of an emergency, disaster, or crisis.

At the beginning of each school year, School Site Councils/School Safety Committees update their site-specific Emergency Plan. The site-specific Emergency Plan includes the site safety plan, Placer County Office of Education's Disaster Plan, updated site maps/evacuation routes, and Emergency Medical Services Authority (EMSA) Emergency First Aid Guidelines for California Schools. Schools are issued first aid kits and "grab and go" emergency packs in the event of an evacuation and Emergency Supply Kits for use during lockdowns or shelter in place situations. In addition, our school nurses work with staff & parents/guardians of students with special needs to provide medical emergency kits following Individualized School Health Plans.

The safety plan was last approved by the County Superintendent of Schools in February 2021.
