2021-22 School Overview

The Placer County Office of Education is committed to promoting students' emotional, social, and academic growth. We aim to cultivate a child's potential within a therapeutic setting to facilitate their return to a less restrictive environment. The process is accomplished by implementing Positive Behavior Intervention and Supports (PBIS) and providing integrated mental health and educational services for students and families. The Nurtured Heart Approach, which emphasizes the greatness inherent to each child, is effectively practiced throughout the instructional day.

The Placer County Office of Education ESTEEM (Encouraging Socialization Through Energizing and Empathy for Mutual Success) program is designed for special education students whose emotional/behavioral problems have adversely affected their academic development and require an intensive and comprehensive placement. Along with individual Behavioral Support Plans, the program is based on school-wide Positive Behavioral Interventions & Supports and Social Skills Groups along with the Nurtured Heart Philosophy. Their district of residence must refer students.

The ESTEEM Program consists of social/emotional support integrated throughout the school day and school setting. School staff will provide intensive academic and behavioral support through specialized academic instruction and case management (service coordination, plan development, and progress toward goals). Social skills groups will be provided, and crisis management will be offered when needed throughout the school day. Home/school communication and parent support are essential components of the program. Individual therapy and behavior services will be provided per IEP. A social worker and a behavior specialist will be on-site and available to work with staff and students.

Academic achievement is a vital part of the program. The educational program follows the state standards and frameworks and utilizes state-and-board adopted textbooks. Instruction is individualized to meet IEP goals and objectives. The transition back to the district is an integral part of the program and is addressed individually. During the 2021-2022 school year, 22 3rd through 12th-grade students were enrolled at Sierra Vista School. 15.38% Hispanic, 76.92% White, 7.69% Multiple, 0.00% English Learners, 100% Special Education, 38.46% Socio-Economically Disadvantaged, 13.33% Foster Youth.

2021-22 Quality, Currency, Availability of Textbooks and Other Instructional Materials

Placer County Office of Education held a public hearing on September 9th, 2021. It determined that each school within the district had sufficient and good quality textbooks, instructional materials, or science lab equipment according to the settlement of Williams vs. the State of California.

All students, including English language learners, are given individual standards-aligned textbooks or instructional materials in core subjects for use in the classroom and to take home. Books and supplementary materials are adopted according to a cycle developed by the California Department of Education, making the textbooks the most current available in the school. All teachers review materials approved for use by the State, and a recommendation is made to the School Board by a selection committee composed of teachers and administrators. Before adoption, all recommended materials are available for parent examination at the district office. The table displays information about the quality, currency, and availability of the standards-aligned textbooks and other instructional materials used at the school.

Statewide Assessments

Where the most viable option, LEAs were required to administer the statewide summative assessment in ELA and mathematics. Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. The assessments were required to be:

- Aligned with CA CCSS for ELA and mathematics;
- Available to students in grades 3 through 8, and grade 11; and
- Uniformly administered across a grade, grade span, school, or district to all eligible students.

Options

Note that the CAAs could only be administered in-person following health and safety requirements. If it was not viable for the LEA to administer the CAAs in person with health and safety guidelines in place, the LEA was directed to not administer the tests. There were no other assessment options available for the CAAs. Schools administered the Smarter Balanced Summative Assessments for ELA and mathematics, other assessments that meet the SBE criteria, or a combination of both, and they could only choose one of the following:

- Smarter Balanced ELA and mathematics summative assessments;
- Other assessments meeting the SBE criteria; or
- Combination of Smarter Balanced ELA and mathematics summative assessments and other assessments.

2021-22 School Safety Plan

All Placer County Office of Education (PCOE) school sites are in the process of updating their 2021-2022 comprehensive school safety plan in accordance with Superintendent Policy 0450 to fulfill the requirements of California Education Code 32280 through 32289. In compliance with SB 187, the plan will be reviewed and revised annually for each school site by the School Site Council/School Safety Committee, reviewed in consultation with law enforcement and first responders, and approved by the County Superintendent of Schools by March 1, 2022. Site safety plans are aligned with the National Incident Management System (NIMS) and California Standardized Emergency Management Systems (SEMS) utilizing the Incident Command System (ICS). Each document is prepared for employees to use at specific school sites in the event of an emergency, disaster, or crisis.

At the beginning of each school year, School Site Councils/School Safety Committees update their site-specific Emergency Plan. The site-specific Emergency Plan includes the site safety plan, Placer County Office of Education's Disaster Plan, updated site maps/evacuation routes, and Emergency Medical Services Authority (EMSA) Emergency First Aid Guidelines for California Schools. Schools are issued first aid kits and "grab and go" emergency packs in the event of an evacuation and Emergency Supply Kits for use during lockdowns or shelter in place situations. In addition, our school nurses work with staff & parents/guardians of students with special needs to provide medical emergency kits following Individualized School Health Plans.

The safety plan was last approved by the County Superintendent of Schools in February 2021.
