<p>The Placer County Office of Education is committed to promoting students' emotional, social, and academic growth. We aim to cultivate a child's potential within a therapeutic setting to facilitate their return to a less restrictive environment. The process is accomplished by implementing Positive Behavior Intervention and Supports (PBIS) and providing students and families with integrated mental health and educational services. In addition, the Nurtured Heart Approach emphasizes the greatness inherent to each child and is effectively practiced throughout the instructional day.</p> <p>The Placer County Office of Education ESTEEM (Encouraging Socialization Through Energizing and Empathy for Mutual</p>

Success) program is designed for special education students whose emotional/behavioral problems adversely affect their academic development and require an intensive and comprehensive placement. Along with individual Behavioral Support Plans, the program is based on school-wide Positive Behavioral Interventions and Supports, Social Skills Groups, and the Nurtured Heart Philosophy. In addition, the District of Special Education Accountability must refer students to Sierra Vista.

The ESTEEM Program consists of social/emotional support integrated throughout the school day and school setting. School staff will provide intensive academic and behavioral support through specialized instruction and case management (service coordination, plan development, and progress toward goals). Social skills groups will be provided, and crisis management will be offered when needed throughout the school day. Home/school communication and parent support are essential components of the program. Individual therapy and behavior services will be provided per IEP. A social worker and a behavior specialist will be on-site and available to work with staff and students.

Academic achievement is a vital part of the program. The educational program follows the state standards and frameworks and utilizes state-and-board adopted textbooks. Instruction is individualized to meet IEP goals and objectives. The transition back to the district is an integral part of the program and is addressed individually. During the 2023-2024 school year, 21 (3rd to 12th-grade) students were enrolled at Sierra Vista School. Sierra Vista School is WASC accredited.

In compliance with BS 187, the plan is reviewed and revised annually for each school site by the School Safety Committee, reviewed in consultation with law

enforcement and first responders, and approved by the County Superintendent of Schools by March 1 of every year. Site safety plans are aligned with the National Incident Management System (NIMS) and California Standardized Emergency Management Systems (SEMS) utilizing the Incident Command System (ICS). Each document is prepared for employees to use at specific school sites in the event of an emergency, disaster, or crisis.

At the beginning of each school year, Sierra Vista School's School Safety Committees update the site-specific Emergency Plan. The site-specific Emergency Plan includes the site safety plan, Placer County Office of Education's Disaster Plan, updated site maps/evacuation routes, and Emergency Medical Services Authority (EMSA) Emergency First Aid Guidelines for California Schools. Sierra Vista School was issued first aid kits and "grab and go" emergency packs in the event of an evacuation and Emergency Supply Kits for use during lockdowns or shelter-in-place situations. In addition, Sierra Vista School nurses work with staff & parents/guardians of students with special needs to provide medical emergency kits following Individualized School Health Plans.
