2025-26 School Description and Mission Statement

Mission Statement: The Student Services Division will increase student achievement through meaningful and rigorous instruction for all students.

Situated in the Sierra Foothills, the Placer County Office of Education (PCOE) serves over 75,000 students in 16 school districts across Placer County. To serve the students of Placer County, PCOE provides an array of programs and services to meet student needs. This task is accomplished by providing high-quality, specialized programs for students, recruiting, retaining, and developing highly qualified staff, and monitoring fiscal accountability and expenditures.

The Placer County Office of Education operates the Placer County Court School in Auburn, serving students from the community who are incarcerated. Placer County Court School provides intensive intervention tailored to students' academic and social-emotional needs. Common Core standards-based curriculum and instruction are provided to all students. Group instruction, as well as individualized interventions, facilitate academic, social, and emotional achievement. Honour Schaps Court School has a low staff-to-student ratio, enabling teachers to provide differentiated, meaningful, and rigorous instruction to all students. Some teachers hold general and special education teaching credentials, allowing them to serve as IEP case managers and provide the appropriate special education services to students enrolled in the Court School. Placer County Court School partners with Placer County Probation to provide counseling to students who need social-emotional support and interventions related to anger management and decision-making. Academic counseling, career exploration, and college courses are provided to students. A broad course of study is available using a blended model of in-class instruction and online coursework.

In the 2023-2024 school year, the average student enrollment at the Placer County Court School was 15 days. According to 2023-2024 data from Data Quest, the stability rate of Honour Schaps Court School was 0.8%. One out of 125 students had stable enrollment (enrolled for 245 consecutive calendar days at the same school without a disqualifying exit). In comparison, Placer County's stability rate is 92.3%, and the statewide rate is 91%.

The Placer County Court School provides intensive intervention tailored to students' academic and social-emotional needs. Common Core State Standards-based curriculum and instruction are provided to all students. Whole group instruction, as well

as individualized interventions, facilitate academic, social, and emotional achievement. The School has a low staff-to-student ratio, which enables teachers to provide differentiated, meaningful, and rigorous instruction. In addition, Placer County Court School provides counseling to students who benefit from social-emotional support and interventions related to anger management and appropriate choice-making. Academic and Career Counseling is provided, and a broad course of study is available using a blended model of in-class instruction and online coursework. The Placer County Court School is WASC accredited.

2025-26 Quality, Currency, Availability of Textbooks and Other Instructional Materials

Placer County Office of Education held a public hearing on August 14, 2025. The Board determined that each school within the district had sufficient and good quality textbooks, instructional materials, and science lab equipment according to the settlement of Williams vs. the State of California.

All students, including English Learners, are given individual standards-aligned textbooks or instructional materials in core subjects for use in the classroom and to take home. Books and supplementary materials are adopted according to a cycle developed by the California Department of Education, making the textbooks the most current available in the school. All teachers review materials approved for use by the State, and a recommendation is made to the School Board by a selection committee composed of teachers and administrators. Before adoption, all recommended materials are available for parent examination at the district office. The table displays information about the quality, currency, and availability of the standards-aligned textbooks and other instructional materials used at the school.

The Placer County Office of Education (PCOE) makes great efforts to ensure all its school sites are clean, safe, and functional. 2025-26 School Safety Plan

Placer County Court School has an updated and approved Comprehensive Safe School Plan in accordance with Superintendent Policy 0450 to fulfill the requirements of California Education Code 32280 through 32289. In compliance with BS 187, the plan is reviewed and revised annually for each school site by the School Safety Committee, reviewed in consultation with law enforcement and first responders, and approved by the County Superintendent of Schools by March 1 every year. Site safety plans are aligned with the National Incident Management System (NIMS) and California Standardized Emergency Management Systems (SEMS) utilizing the Incident Command System (ICS). Each document is prepared for employees to use at specific school sites during an emergency, disaster, or crisis.

Placer County Court School's School Safety Committees update the site-specific Emergency Plan at the beginning of each school year. The site-specific Emergency Plan includes the site safety plan, Placer County Office of Education's Disaster Plan, updated site maps/evacuation routes, and Emergency Medical Services Authority (EMSA) Emergency First Aid Guidelines for California Schools. Placer County Court School is issued first aid kits, "grab and go" emergency packs in the event of an evacuation, and emergency supply kits for use during lockdowns or shelter-in-place situations. In addition, Placer County Court School nurses work with staff & parents/guardians of students with special needs to provide medical emergency kits following Individualized School Health Plans.
