2025-26 School Description and Mission Statement

FROM THE 2025 WASC:

The Placer County Office of Education operates Sierra Vista School, a special education program for students whose emotional and behavioral challenges adversely affect their education and who have been referred by their district of residence. The program aims to deliver intensive support to students and their families to meet their academic, behavioral, and social-emotional goals, transition to a less restrictive environment, become contributing and productive community members, and graduate high school.

The educational program follows state standards and frameworks and utilizes current state and board-adopted textbooks. High-quality research-based instruction and the use of assessment data guide instruction, IEP goals, and student plans. Whole group and individual instruction meet students' unique learning needs.

Sierra Vista cultivates resilience and social-emotional wellness through a whole-child collaborative approach. The program utilizes prevention-based frameworks such as school-wide Positive Behavioral Interventions & Supports (PBIS) and the Nurtured Heart Philosophy to help support positive student behavior and success. A school social worker and school psychologist provide individual and group counseling to support students in their educational environments. The site culture is rooted in building healthy relationships that model caring, respect, and empathy. A behavior specialist provides behavioral support to reduce behaviors that interfere with learning.

The team aims to create environments where students feel safe making mistakes, feel connected to staff and peers, and express themselves without fear of judgment.

Sierra Vista is WASC accredited.

The Placer County Office of Education (PCOE) makes great efforts to ensure all its school sites are clean, safe, and functional. To ensure these goals and objectives are met, PCOE employs custodial & maintenance staff or contracts with partner districts for nightly cleaning services and routine maintenance of all facilities it owns, leases, or operates. Each facility is inspected yearly on or about July 1st of each school year. 2025-26 School Safety Plan

Sierra Vista School has an updated and approved Comprehensive Safe School Plan per Superintendent Policy 0450 to fulfill the requirements of California Education Code 32280 through 32289 requirements. In compliance with BS 187, the plan is reviewed and revised annually for each school site by the School Safety Committee, reviewed in consultation with law enforcement and first responders, and approved by the County Superintendent of Schools by March 1 of every year. Site safety plans are aligned with the National Incident Management System (NIMS) and California Standardized Emergency Management Systems (SEMS) utilizing the Incident Command System (ICS). Each document is prepared for employees to use at specific school sites in the event of an emergency, disaster, or crisis.

At the beginning of each school year, Sierra Vista School's School Safety Committees update the site-specific Emergency Plan. The site-specific Emergency Plan includes the site safety plan, Placer County Office of Education's Disaster Plan, updated site maps/evacuation routes, and Emergency Medical Services Authority (EMSA) Emergency First Aid Guidelines for California Schools. Sierra Vista School was issued first aid kits and "grab and go" emergency packs in the event of an evacuation and Emergency Supply Kits for use during lockdowns or shelter-in-place situations. In addition, Sierra Vista School nurses work with staff & parents/guardians of students with special needs to provide medical emergency kits following Individualized School Health Plans.
